The scope for demolition & rectification works has been revised as follows:

1. Demolition and reconstruction of boundary wall at plot S3 – 06A has been omitted from the project.
2. BOQ item 2.2 under section 7 of original announcement has been amended by bifurcating into BOQ item 2.2 and BOQ item 2.3 of amendment for Removal of existing street lights and relocation of Existing distribution boxes, junction boxes respectively. Respective BOQ and drawings are attached and shall be considered part of this amendment.
3. Drawing set under Section 9 of original announcement has been amended by bifurcating into two set. Namely
 - a. “Thilafushi Pilot Road Project Road Drawings” – for all road development Works under the Project’s Scope.
 - b. “Site Adjustment & Removal & Relocation Plan” – for rectification/adjustment to existing services/object/obstructions etc. under the Project’s Scope.
4. As built layout included in the drawing set for reference (Refer file “Thilafushi Pilot Road - Existing Services Plan”).
5. Minor revision to Specifications.

1. Section-2 Instruction to Bidders (Bid Security) Clause 17.1, has been revised as follows.


